\$20,971 - Scholarship Fund: Support to our partner primary school to subsidize tuition for 400 children ages 4-15, funds evenly distributed among 48 secondary students to alleviate the financial pressure of continued education, and a scholarship provided to a university student obtaining a degree in Civil Engineering.

\$14,100 - Program Supplies: Supplies for running Action In Africa's community center in Kampala, health services supplies, and supplies for the organization's various outreach programs.

\$5,802 - Travel Expenses: Expenses for AIA staff members traveling between the US and Uganda.

\$2,493 - Ground Transportation: On-the-ground transportation expenses related to transporting volunteers to/from the airport, transporting AIA staff members for health services home visits, and trips into Kampala for supplies.

\$2,108 - Advertising Expenses

\$1,082 - Meals and Entertainment: Meals for AIA staff members and scholarship recipients during AIA meetings and events.

\$549 - Bank service charges

\$151 - Fund raising campaign costs
